Terms & Conditions

- a) Any additional Customs / Port charges applicable would be charged at actual.
- b) Rates are quoted based on current port tariff, and are subject to change if any on actual commencement of shipment.
- c) Details on the B/L, Invoice, Packing list & Certificate of origin should be the same and should not differ as it might delay clearance procedure.
- d) Customs Duty 5% of the CIF value or at actuals
- e) Duty Outlay 2.5% are applicable
- f) Rates are excluding all inspection, storage, legalization, any govt levies etc.
- f) 24 hours needed before any requirement

Exclusion:

- Insurance of any kind, duty, deposit, demurrage, storage, packing/unpacking of cargo, crane/forklift/labor require for unloading/loading cargo at site, transport detention charges if any
- Free time for loading cargo at site is 2 hours thereafter will be charged additional .
- Any special equipment required for loading cargo at site, or Any other charges levied by the Shipping line / Customs /Port authorities
